



## Reservation List Puppy Contract

(Delivery fee based on distance and flights are based on current prices, please contact for further info)

### The Seller and Purchaser agree to the following:

1. A deposit of **\$500.00** USD **paid with PayPal** places Purchaser on the Reservation List for one (1) puppy.
2. There must be a deposit of \$500.00 or partial payments that add up to \$ 500.00 per puppy. A **PayPal** payment of total **\$ 500.00** makes this contract binding automatically. Paying more than the \$500.00 USD deposit will not bump you up higher on the list.
3. Purchaser is added to the Reservation List in the order that the deposit is received.
4. Deposit is non-refundable, but non-expiring. Purchaser can pass to wait for future litters.
5. Puppy(s) can be picked up or delivered between eight (8) and ten (10) weeks old, and can fly between ten (10) and twelve (12) weeks old. Waiting longer may require boarding fees.
6. Final balance is due two (2) weeks prior to flight, pick up or delivery. If final payment is not received within this time frame, puppy(s) will be made available for others to purchase and Purchaser will be added back down to the bottom of the Reservation List.
7. Purchaser will take puppy(s) (at Purchasers expense) to a veterinarian for complete exam within 72 hours of receiving. If Purchaser has other pets, puppy(s) will be quarantined until then.
8. Purchaser will supply sanitary facilities for puppy(s), including clean water and food daily.
9. Seller guarantees that puppy(s) is in sound health and not harboring any disease or parasites. Seller will supply Purchaser with puppy(s) health certificate. Seller guarantees general health of puppy(s) for seven (7) days on the condition that the Purchaser has kept puppy(s) in proper living environment listed above and is kept quarantined during this time.
10. Seller guarantees that puppy(s) is free of hereditary malformation (genetic defects) to the best of the Seller's knowledge at the time of the sale. In the event that a hereditary malformation is found within one (1) year of purchase, Seller agrees to replace puppy(s) with another puppy(s) of equal worth or refund full price of puppy(s) with their return. No medical or shipping costs will be refunded. No injuries or conditions as a result of accident or poor living situations will be covered by Seller, this includes cherry eye, skin conditions, sinus related issues, joint problems or heat stroke.
11. If living in a warm climate, puppy(s) will either be indoors or have indoor access at all times.
12. This puppy(s) is purchased as a pet and will be spayed/neutered before one year of age. Recommendation is six (6) months of age. Seller will provide AKC Registration instructions upon receiving dated documentation of alteration. If Purchaser does not alter puppy(s) by one (1) year of age, the Purchaser shall owe the Seller an additional \$2,000.00 to receive AKC instructions.
13. By validating this agreement by the PayPal requested payment, Purchaser agrees that any violation of these conditions will result in the return of puppy(s) and any legal action will be filed in Tampa, FL and costs paid for by the Purchaser.
